- Each vehicle requires a separate permit
- Each vehicle must have the office of the Village of Orchard Park sticker affixed to vehicle window in appropriate manner
- No plow operator will plow snow across or into the roadway, Right of Way or obstructing sidewalks leaving snow piles or drifts that will create a hazard to traffic or pedestrians.
- Sidewalks must not be covered, blocked or impeded in any way that affects access
- Homeowners plowing his/her own property and for their use only are exempt from this permit but are still bound by the applicable rules and regulations
- Applications can be revoked or suspended at any time if provisions of this ordinance are not met
- Any damage done in the Right of Way will be the property owner/occupants's responsibility
- If the Village of Orchard Park DPW is required to remove snow due to the failure to comply to this ordinance, the property owner/occupant will be charged \$180/hr for each piece of equipment and driver to remove the nonconforming snow.
