Minutes Village of Orchard Park Board of Trustees

The regular meeting of the Board of Trustees of the Village of Orchard Park was held on Monday, March 27, 2023 in the Municipal Center, 4295 South Buffalo Street, Orchard Park, New York. Mayor Clinton called the meeting to order at 7:00 p.m. with the Pledge of Allegiance to the Flag.

Mayor Clinton made the following announcement:

A public hearing was scheduled and advertised for this time to hear public comment on proposed Local Law #3, 2023. Mayor Clinton opened the meeting with a brief explanation of the Local Law to override the tax cap, which is just under 2%.

Mayor Clinton asked 3 times for comments in favor; there were none. Mayor Clinton asked 3 times for comments in opposition; there were none.

Moved by Trustee Kaczor Rodo, seconded by Trustee Hartung that proposed Local Law #3, 2023 be approved:

To override the tax levy limit established in General Municipal Law §3-c.

SECTION 1: Legislative Intent

It is the intent of this local law to allow the Village of Orchard Park to adopt a budget for the fiscal year commencing 2023-2024 that requires a real property tax levy in excess of the "tax levy limit" as defined by General Municipal Law §3-c.

SECTION 2: Authority

This local law is adopted pursuant to subdivision 5 of General Municipal Law §3-c, which expressly authorizes a local government's governing body to override the property tax cap for the coming fiscal year by the adoption of a local law approved by a vote of sixty percent (60%) of said governing body.

SECTION 3: Tax Levy Limit Override

The Board of Trustees of the Village of Orchard Park, County of Erie, is hereby authorized to adopt a budget for the fiscal year commencing 2023-2024 that requires a real property tax levy in excess of the amount otherwise prescribed in General Municipal Law §3-c.

SECTION 4: Severability

If a court determines that any clause, sentence, paragraph, subdivision, or part of this local law or the application thereof to any person, firm or corporation, or circumstance is invalid or unconstitutional, the court's order or judgment shall no affect, impair, or invalidate the remainder of this local law, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, or part of this local law or in its application to the person, individual, firm or corporation or circumstance, directly involved in the controversy in which such judgment or order shall be rendered.

SECTION 5: EFFECTIVE DATE: This local law shall take effect immediately and will be filed with the Secretary of State.

Moved by Trustee Hartung, seconded by Trustee Hogenkamp that proposed Local Law #4, 2023 be approved:

Amending Chapter 194 of the Village of Orchard Park Code entitled "Taxation", Article VI, "Volunteer Firefighters and ambulance Workers Exemption", as follows:

Amend Section 3: Eligibility requirements to read:

Such exemption shall be granted to an enrolled member of an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service within the Orchard Park Fire District provided that:

A. The property is owned by the volunteer firefighter or volunteer ambulance worker. The volunteer shall be named on the deed, but other individuals may be named on the deed as well.

B. The property is the primary residence of the volunteer firefighter or volunteer ambulance worker;

C. The property is used exclusively for residential purposes and the property must be classed as a 1-family residential (210) or a 2-family residential (220);

D. The volunteer firefighter or volunteer ambulance worker resides in the Village of Orchard Park and the Village of Orchard Park is served by such incorporated volunteer fire company, fire department or incorporated voluntary ambulance service;

E. The volunteer firefighter or volunteer ambulance worker is certified by the authority having jurisdiction as an enrolled member of such an incorporated volunteer fire company, fire department, or incorporated voluntary ambulance service; and

F. The volunteer firefighter or volunteer ambulance worker meets the minimum service requirement established by the Village of Orchard Park, which is hereby established as 5 years.

Amend Section 5: Certification to read:

The Orchard Park Fire District must annually file with the assessor, prior to the applicable taxable status date, a list of active volunteer members who are certified to meet the minimum service requirement. Such list must provide, as of the applicable taxable status date, the number of years of service served by each such enrolled member and such enrolled member's address of residence.

Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.
