- Garbage fee increase of \$23 to \$232 from \$205 per year (still lower than the Town of Orchard Park)
- Increase in the contribution to reserves
- Scheduled 4 road projects and a waterline replacement
- Purchasing leak detection equipment that will expectantly save money by reducing line loss.
- Purchasing fuel tanks to promote self-sufficiency.
