Whereas, on November 17, 2022, several Villages in Western New York were significantly impacted by an epic snow storm that led to over 7 feet of snow falling in our communities; and

Whereas, the impact of the storm was severe and led to the declaration of a multiple-day travel ban and, in some communities, required massive snow removal efforts; and

Whereas, FEMA has determined that communities impacted by the storm are eligible for reimbursement for certain costs but that costs associated with snow removal are deemed ineligible; and

Whereas, we believe that if a snow storm of this magnitude did not result in snow removal costs being eligible for reimbursement that perhaps the criteria for making this decision needs to be reviewed and/or revised; and

Now therefore be it resolved by the Orchard Park Village Board of Trustees that:

- 1) We believe that due to the severity of the November 2022 storm, snow removal costs should be considered as an eligible expense through the FEMA reimbursement process.
- 2) We request that our elected leaders assist our communities by reaching out to decision-makers at FEMA and New York State to review and revise the eligibility criteria as it relates to the eligibility of snow removal costs.
