It shall be the duty of the owner or occupant of any real property located within the Village of Orchard Park to cut, trim, remove or cause to be cut, trimmed or removed from said lot, plot or property or any portion thereof, all brush thereon, so the general height is no greater than (6) six inches during the months of May through October of each year and to remove from such real property any accumulation of rubbish or trash thereon.

SECTION II: Effective date.

This local law shall take effect immediately upon filing with the Secretary of State.
