NOW, THEREFORE, the Board of Trustees of the Village of Orchard Park, duly convened does hereby

RESOLVE, that the Board of Trustees of the Village of Orchard Park hereby approves the above subject project, and it is further

RESOLVED that the Board of Trustees of the Village of Orchard Park hereby authorizes the Village of Orchard Park to pay 100% of the project costs, and it is further RESOLVED, that the sum of \$2,600,000 is hereby appropriated through bond debt to cover the costs of the project, and it is further

RESOLVED, that Mayor Jo Ann Litwin Clinton of the Village of Orchard Park is hereby authorized to execute all necessary agreements, certifications and reimbursement requests for New York State and/or Federal aid with the New York State Environmental Facilities Corporation in connection with the advancement and/or approval of the project, and it is further

RESOLVED, that a certified copy of this resolution be filed with the appropriate New York State Agency and/or Public Corporation and that there be attached thereto any necessary documents in connection with the project.; and it is further

RESOLVED, that this Resolution shall take effect immediately.
